Crew Member Statement

I have read and understand the Notice of Race, particularly paragraphs 6, 7.7, 15, 34 and 36. I have arranged suitable and adequate personal insurance. I understand that offshore racing can be dangerous. I am healthy and fit for a race as outlined in the ISAF Offshore Special Regulations. I understand that under RRS (Racing Rules of Sailing) 1.2 it is my individual responsibility to wear personal buoyancy adequate for the conditions.

With my signature on the attached crew list I hereby waive any and all claims for myself and my heirs, legal representatives, successors, and assigns, which any of them may have against the organizers (Baltic Sprint Cup Committee, Stavanger Sailing Club, Royal Gothenburg Sailing Club, Århus Sailing Club, the Royal Danish Yacht Club and Warnemünder Sailing Club and their individual members) and all assisting organizations and individuals, their employees and agents and event sponsors and their employees and agents arising out of my participation in the Baltic Sprint Cup 2006 and its related activities and I agree that the foregoing organizations and individuals have no responsibility for the loss of life or injury to any person or persons or for the loss of or damage to any vessel or property.
